

Article 10 - Homepage on Internet

Rev Smith proposes that the Acts of Synod be published on the FRCA website on the proviso that matters of a personal nature are excluded and that discretion be used in matters relating to other churches.

ADOPTED

Article 11 - Welcome to Overseas Visitors

The chairman welcomes delegates P Drijfhout and J Houweling of the RCNr, seated under 6.2 of the Rules for Synod, and Rev P Archbald of the RCNZ, seated under 6.3 of the Rules for Synod. No credentials are received for these delegates, though Synod did receive letters that they were delegated to this Synod.

Article 12 - Synod advisors and Closed session

The moderamen have decided that there are no advisers, nor advisory committees, nor closed sessions needed for this Synod.

Article 13 - Agenda Items Schedule

The chairman distributes and explains a schedule for dealing with the items on Synod's agenda.

Article 14 - Overseas Visitors Indicate Agreement to Three Forms of Unity

The chairman asks delegates of RCNr and RCNZ to rise to indicate their agreement with the Three Forms of Unity. The brothers rise.

Article 15 - Overture from Southern River re Article 13 Synod West Kelmscott

I. Material:

8d - FRC Southern River Overture re Art 13 Acts Synod 2006 re non delegated ministers being invited as advisors to Synod.

This item is declared admissible because it arrived on time and from the churches

II. Recommendation:

To deny the overture of Southern River.

Grounds:

- 1. The admission and function of advisers at Synod is adequately covered in the Rules for Synod 5.1 and 5.2.
- 2. Southern River does not request a change to these rules.

III. Amendment: to add ground 3:

 Synod West Kelmscott did not intend to set a precedent (Acts Synod West Kelmscott, Article 13).

THE AMENDMENT IS ADOPTED THE AMENDED RECOMMENDATION IS ADOPTED

Article 16 - Overture from Mt Nasura re Deputies' mandates and authority

I. Material:

8bb - FRC Mt Nasura Overture re Deputyships

II. Overture:

Mt Nasura asks Synod 1. to ensure that deputies' mandates are clear and concise and that deputies are held properly accountable for the manner in which they have executed their task; 2. to use clear language in its recorded decisions and 3. to explicitly record that deputies' reports have no formal status.

This item is declared admissible.

III. Recommendation:

Synod takes note of Mt Nasura's overture and decides that this overture needs no formal decision since deputies reports are exactly what they are, working documents of synod (Rule 10 of Rules for Synod).

ADOPTED

Article 17 - Training for the Ministry

I. Materials:

12 e - Deputies Report

8I – FRC Southern River Overture re Deputies for Training for the Ministry report

8n - FRC Darling Downs Overture re Deputies for Training for the Ministry report

Items 8I and 8n are declared admissible.

II. Recommendations of the Deputies Report:

Deputies recommend that Synod decides to:

- 13.1 Request the churches to contribute A\$50 per communicant member per annum for the maintenance of Hamilton as from 1 January 2009.
- 13.2 Set aside \$6,000 from general Synod funds for the costs of a visit to Australia by a guest lecturer from Hamilton or Kampen, together with his wife.
- 13.3 Set aside \$3,500 from general Synod funds for travelling and accommodation costs of a delegate of Deputies to attend a meeting of Hamilton's Board of Governors in September 2009, being the 40th Anniversary of the Hamilton College.
- 13.4 Adopt the Australian adaptation of the guidelines for the Pastoral Training Program prepared by Deputies.
- 13.5 Discharge Deputies and to appoint new deputies with the mandate to:
 - continue to collect funds for "Hamilton" and forward them to the College;
 - continue to correspond with "Hamilton", "South Africa", "Kampen" and "Korea" in order to maintain contact and obtain information:
 - 3. continue to collect funds for our own theological library and theological training;
 - 4. continue with our own theological library;
 - 5. continue to ensure that relevant information is published concerning the training for the ministry, so that the churches understand the need to support the colleges and the training of the students:

- continue to arrange the support of theological students whenever required in accordance with Art 18 CO, and as agreed in Art 50 of Acts of Synod 1992 as amended by Art 56 of Acts of Synod 1994;
- 7. continue to make arrangements for a guest lecturer from one of the theological seminaries of our sister churches once every three years;
- continue to be as closely involved in the work of the Board of Governors of Hamilton as practically possible;
- monitor the practical implications of including the Australian Churches in the Pastoral Training Program of the Hamilton College and collect and disburse funds for this purpose in accordance with the Australian adaptation of the guidelines for the Pastoral Training Program;
- investigate the feasibility of offering a basis year of theology to the churches in Australia, for the purpose of establishing a Theological University in the future.

III. 8I - Overture of Southern River:

Southern River proposes that recommendation 1 of Deputies be amended to increase the contribution amount to A\$65 per communicant member per annum.

- Deputies have not recommended any increase to the contribution amount to that decided upon by Synod 2006.
- Our Canadian sisters contribute an amount of CAN\$69 per communicant member per annum. On the present exchange rate this equates to around A\$80.
- The FRCA make full use of the Theological College of the Canadian Reformed Churches, both with respect to the training of FRCA men for the ministry and for the calling of ministers.
- The churches are responsible to ensure that the ministry of the gospel be maintained, and ought to take full financial responsibility for this.
- In general terms, the FRCA churches are financially blessed and can be expected to bear the increased contribution amount.
- 6. The FRCA do not presently have any immediate plans to develop their own institution for theological training.

- 7. In the event that the FRCA do (at some time in the future) develop their own theological training, the contribution towards Canada could be reduced to allow the FRCA to absorb the cost of our own training costs. This would coincide with our reduced use of Canada's Theological College.
- 8. The increase to A\$65 allows for a stepped increase, with a view to matching the contribution of our Canadian sisters in 2012. A stepped increase (rather than an immediate increase to A\$80) is for the purpose of allowing this to be properly allowed for in the budgets of the churches within the bond.

Amendment:

To delete Ground 8 because it is a further proposal.

ADOPTED

THE AMENDED PROPOSAL IS PUT TO THE VOTE AND ADOPTED

IV. 8I - Overture of Southern River:

Southern River proposes that recommendation 3 of Deputies not be accepted (i.e. there be no funds set aside for the purposes of attending the Hamilton College in September 2009).

Grounds

- The recommendation of Deputies is made on the assumption that there is a tangible benefit to attendance in person by a Deputy in Hamilton
- Deputies' report does not mention what such benefits are, how these benefits are expected to be achieved by an attendance of a Deputy in Hamilton, and/or whether there are other ways of achieving these benefits.
- 3. The Deputies do not include any report regarding the attendance in Hamilton by a Deputy in September 2008 which addresses an account of what was done, what the objectives of the attendance were and an analysis of whether these were achieved.
- 4. It is for Deputies to demonstrate that an attendance is necessary and beneficial.

DFFFATFD

V. 8I – Overture Southern River

Southern River proposes to discontinue the collection of funds for our own theological library. Since it may be argued that this matter has been proposed previously (see Article 16 of the Acts of Synod 2006), Southern River gives the following new Grounds:

- 1. As at November 2008, the Australian Theological Library Fund had a balance of around \$70,000.
- Deputies are yet to purchase any theological books or materials, noting that such material will become outdated prior to being put to use.
- 3. It is apparent from Deputies' report that there is no immediate intention to commence purchasing materials.
- 4. The Fund of \$70,000 is an adequate resource from which any necessary materials can be purchased over the next 3 years, should this occur.
- If additional funds for a Theological Library are required at some time in the future, further money can be collected at that time. We trust that the Lord will provide the necessary funds if and when they are required.

VI. Amendment:

To delete grounds 1,2,3.

Grounds:

- 1. Ground 1 is not a ground.
- 2. Ground 2 is no reason to discontinue collection of funds.
- Ground 3 is not admissible because synod needs to decide whether deputies will purchase materials.

ADOPTED

VII. The amended proposal is put to the vote and adopted.

VIII. 8n – FRC Darling Downs Overture re Deputies for Training for the Ministry report

Darling Downs proposes:

 that Synod decide to instruct the deputies to address the College on the point of the temporary appointment of an instructor, who is not a member of a sister church of our Canadian sister churches. To remind them that our support of the college is based on the fact that we agree with their foundation, and the by-laws that go with that. That we are therefore concerned with this course of action, and urges the college to abide by the instructions of our Lord Jesus Christ to let its yes be yes by sticking to its bylaws, especially those of a principal nature.

 that an additional mandate be given to Deputies for Training for the Ministry, namely, to report matters of concern to the churches.

IX. Recommendation:

Not to adopt the proposal of Darling Downs

Grounds:

- The bylaws concern the governance of the Theological College and are therefore a matter for the Canadian Reformed Churches which maintain it, not for the FRCA which support it.
- Our support of the Theological College is not based on the bylaws but on the sister relationship which we enjoy with the CanRC.
- The suggestion to report matters of concern to the churches falls within the general mandate of deputies to report to the churches and thus does not require an additional mandate.
- 4. The Board of Governors has acknowledged that they wrongly applied the bylaws of the Theological College when appointing a temporary instructor.

DEFEATED

X. Recommendation:

- To instruct Deputies for sister church relations to inform the CanRC that our support for their theological college is based on the fact that we agree with their foundation and the bylaws that go with it.
- 2. To modify the mandate for the Deputies for the Training of the Ministry (insert 13.5.h: "and to report relevant matters to the churches).

Grounds:

 The Board of Governors has acknowledged that they wrongly applied the by-laws, but they still insist that it was legitimate in light of the circumstances. 2. It is regrettable that our deputies did not report this matter to the churches

DEFEATED

XI. Recommendation:

- In view of the temporary appointment of a non-sister church lecturer, to grant the request of the Church of Darling Downs by reminding the Canadian Churches that our support of the college is based on the fact that we agree with their foundation and by-laws so that their maintenance remains highly important to us.
- To note that the deputies' mandate to "maintain contact and obtain information" includes that information which may cause concern is reported to Synod.

Grounds:

- Deputies Training for the Ministry are appointed in view of Church Order Article 17 so that the churches are assured the Australian theological students receive an appropriate training for the ministry.
- 2. The present mandate of deputies "to maintain contact and obtain information" sufficiently includes matter that may be of concern. Just what matters ought to be reported and helpful for the churches is entrusted to the appointed deputies.

ADOPTED

XII. Motion:

To add 13k to Deputies recommendations: investigate the possibilities of theological training by extension (IT).

Grounds: Even though Hamilton at this point in time is reluctant to explore the use of distance learning/IT, there may be opportunities that arise among our sister churches.

ADOPTED

XIII. Final Decision

Synod decides to:

13.1 Request the churches to contribute A\$65 per communicant

- member per annum for the maintenance of Hamilton as from 1 January 2009.
- 13.2 Set aside \$6,000 from general Synod funds for the costs of a visit to Australia by a guest lecturer from Hamilton or Kampen, together with his wife.
- 13.3 Set aside \$3,500 from general Synod funds for travelling and accommodation costs of a delegate of Deputies to attend a meeting of Hamilton's Board of Governors in September 2009, being the 40th Anniversary of the Hamilton College.
- 13.4 Adopt the Australian adaptation of the guidelines for the Pastoral Training Program prepared by Deputies.
- 13.5 Discharge Deputies and to appoint new deputies with the mandate to:
 - a. continue to collect funds for "Hamilton" and forward them to the College:
 - b. continue to correspond with "Hamilton", "South Africa", "Kampen" and "Korea" in order to maintain contact and obtain information, noting that the deputies' mandate to "maintain contact and obtain information" includes that information which may cause concern is reported to Synod; further, in view of the temporary appointment of a non-sister church lecturer, to remind the Canadian Churches that our support of the college is based on the fact that we agree with their foundation and by-laws so that their maintenance remains highly important to us.
 - c. continue to collect funds for theological training, but discontinue the collection of funds for our own theological library;
 - d. continue with our own theological library;
 - e. continue to ensure that relevant information is published concerning the training for the ministry, so that the churches understand the need to support the colleges and the training of the students;
 - f. continue to arrange the support of theological students whenever required in accordance with Art 18 CO, and as agreed in Art 50 of Acts of Synod 1992 as amended by Art 56 of Acts of Synod 1994;
 - g. continue to make arrangements for a guest lecturer from one of the theological seminaries of our sister churches once every three years;

- continue to be as closely involved in the work of the Board of Governors of Hamilton as practically possible;
- monitor the practical implications of including the Australian Churches in the Pastoral Training Program of the Hamilton College and collect and disburse funds for this purpose in accordance with the Australian adaptation of the guidelines for the Pastoral Training Program;
- investigate the feasibility of offering a basis year of theology to the churches in Australia, for the purpose of establishing a Theological University in the future.
- k. investigate the possibilities of theological training by extension (IT).

- Deputies have not recommended any increase to the contribution amount to that decided upon by Synod 2006.
- Our Canadian sisters contribute an amount of CAN\$69 per communicant member per annum. On the present exchange rate this equates to around A\$80.
- The FRCA make full use of the Theological College of the Canadian Reformed Churches, both with respect to the training of FRCA men for the ministry and for the calling of ministers.
- The churches are responsible to ensure that the ministry of the gospel be maintained, and ought to take full financial responsibility for this.
- In general terms, the FRCA churches are financially blessed and can be expected to bear the increased contribution amount.
- 6. The FRCA do not presently have any immediate plans to develop their own institution for theological training.
- 7. In the event that the FRCA do (at some time in the future) develop their own theological training, the contribution towards Canada could be reduced to allow the FRCA to absorb the cost of our own training costs. This would coincide with our reduced use of Canada's Theological College.
- 8. The Fund of \$70,000 is an adequate resource from which any necessary materials can be purchased over the next 3 years, should this occur.

- If additional funds for a Theological Library are required at some time in the future, further money can be collected at that time. We trust that the Lord will provide the necessary funds if and when they are required.
- Deputies Training for the Ministry are appointed in view of Church Order Article 17 so that the churches are assured the Australian theological students receive an appropriate training for the ministry.
- 11. The present mandate of deputies "to maintain contact and obtain information" sufficiently includes matter that may be of concern. Just what matters ought to be reported and helpful for the churches is entrusted to the appointed deputies.
- 12. Even though Hamilton at this point in time is reluctant to explore the use of distance learning/IT, there may be opportunities that arise among our sister churches.

ADOPTED

Article 18 - Formation of Three Classes

I. Materials:

10c - Overture Classis South re Formation Three Classes

II. Proposal:

Synod takes note of the submission of Classis South and decides to amend the Rules for Synod 2 as follows: in the event that three Classes will be instituted, the delegation to Synod for each Classis will be three ministers and three elders.

ADOPTED

Synod appoints W Spyker and W Pleiter to prepare a proposed change to article 45 of the Church Order.

Article 19 - Rules for Synod Appeals

I. Materials:

10a - Classis South Overture re Rules for Synod relating to appeals

II. Proposal:

Classis South April 20th 2007, proposed to Synod Launceston [sic] to

add the following to the Rules for Synod for the sake of clarification of Synod and appellants in relation to Appeal to Synod:

Rules concerning appeals to Synod

- For an Appeal to be considered by Synod it must be in the possession of the convening church no later than 42 days before the date that Synod is scheduled to commence.
- Each appeal shall be checked by officer bearers of the convening church appointed by the convening church for the purpose of ensuring that the appeal complies with all of the following criteria for a competent Appeal:
 - a. The Appeal is to be signed, dated, and received by the convening church within the time period required under these Rules:
 - The Appeal shall include the appellants full name(s), address(es) and signature(s);
 - The Appeal shall provide a summary or quotation of the decision that has led to the Appeal, and shall also state the body responsible for that decision, and the date(s) and location(s) of that decision;
 - d. The Appeal shall include a clear statement of what the appellant is asking Synod to do.
 - e. The Appeal shall contain clear statements that provide the issues, facts and contentions involved in the decision that is being Appealed;
 - f. The Appeal shall contain clear statements outlining the grounds of Appeal; and
 - g. Where the Appeal relies upon documents or other evidence, these shall be clearly referenced and attached if practical.
 - h. The convening church is to verify that that the appellant has informed the classis concerned of the appeal against it.
- 3. Within 14 days of receiving an Appeal, the convening church shall provide the Appellant with written advice, confirming whether or not the Appeal complies with the criteria for a competent Appeal pursuant to these rules. Where an Appeal does not comply the Appellant(s) are also advised that an Amended Appeal can be lodged as long as it complies with the applicable rules under point 4
- 4. For an Amended Appeal to be considered by Synod, it shall initially have complied with the 42 day deadline pursuant to rule number one (1) of this part, and the Amended Appeal shall be received by the convening church no later than 21 days before the date that Synod is scheduled to commence.
- 5. The convening church shall ensure that all Appeals submitted

in accordance with rule number one (1) of this part, are included on the Agenda for Synod, irrespective of whether they comply with the criteria for a competent Appeal pursuant to rule number two (2) of this part. If the appellant specifies that the appeal is not to be checked by the convening church, it shall be sent directly to Synod.

- 6. An appellant is entitled to insist that an Appeal, although assessed as not being competent pursuant to rule number two (2) of this part, shall be submitted to Synod, but in doing so greatly increases the possibility that it is declared inadmissible by Synod.
- 7. The convening church will publish the Guidelines for Appeals at least 90 days prior to the convening of Synod.

Grounds:

- Synod(s) have had to spend much time deliberating the admissibility of Appeals that were sent directly to Synod. This has at times cost hours of valuable time.
- Synod(s) have had to try and determine what the Appeal is actually seeking, due to the confusing material submitted.
- 3. The appellant(s) are helped by the proposed rules, in that they are guided to submitting a suitably structured and clear appeal for consideration by Synod. This avoids disappointment of inadmissible or rejected appeals, and the possible result of having to wait for another 3 years before resubmitting.
- The proposed procedure does not seek to add another step in the appeal process, but is an advisory procedure for the benefit of the appellant and broader assembly.

III. Motion:

Not to accede to the proposal of Classis South April 20th 2007 to add new rules concerning appeals to Synod.

- The current rules for admissibility of appeals are already outlined in Rules for Synod 7.3.
- While the publication of the "criteria of an appeal" prior to synod can be helpful, it does not substantiate the need for a 'pre-synod' review committee.
- 3. The proposed rules add another step in the appeal process, and may make the appeal process cumbersome.

- Adding a 'pre-synod' review committee can give the perception that the decision making process may be prejudiced prior to the convening of Synod.
- 5. The determination of admissibility of appeals is an important element of providing justice and peace to the churches and thus belongs in the jurisdiction of Synod.
- While the time spent on admissibility may have been lengthy for past Synods, that does not mean it will always be this way.

ADOPTED

Article 20 - Length of Term of Synod Deputyships

I. Material

8b – FRC Mt Nasura Overture re term of synod appointed deputyships

II. Proposal:

Mt Nasura requests Synod to take the necessary measures to ensure that any future deputy appointments made by Synods are subject to a maximum term of 9 years. Mt Nasura further requests that should Synod accede to this request, this ruling be taken into consideration in the re-appointment of any current deputies, while taking the necessary care that current "committees" are not disabled as a result

Grounds:

- It is "healthy" for deputyships to rotate on a regular basis in order to avoid individual deputies from gaining influence or simply becoming stale.
- The proposed provision will regularly introduce fresh ideas or approaches in to deputyships.
- 3. The proposed provision is the norm within our Canadian and Dutch Sister churches.

III. Amendment:

Having taken note of the submission of Mount Nasura, Synod decides that:

The terms of deputies who are reappointed will, as a rule, be limited to a maximum of 9 years unless Synod decides that there are good reasons to reappoint (eq. to maintain continuity, expertise, etc.).

Grounds:

- It is healthy for deputyships to have new individuals who are able to contribute.
- It is good to maintain continuity and expertise among the deputyships.

ADOPTED

Article 21 - Reformed Churches of Brazil (RCB)

I. Materials

12a - General Secretary's Report

8x - FRC Mt Nasura Overture re General Secretary's report re Reformed Churches of Brazil

II. Overture Mt Nasura

Proposal:

To declare the overture of Mt Nasura inadmissible.

Grounds:

1. This matter has not been dealt with by the minor assemblies, being classis, as per Church Order Article 30.

DEFEATED

III. Proposal:

Mt Nasura requests Synod to ensure that a deputyship be mandated to take up contact with these churches with a view to possible sister church relations, on the grounds mentioned in their letter, as follows.

- The FRCA have fraternal contacts with RCB's sister churches in Holland and Canada.
- The RCB will have contacts with one more church faithful and involved with the Word of God.
- 3. These contacts will create the possibility of exchange of advice and experience for Reformed Faith and Practice.

IV. Amendment:

To add the following: that synod respond to the RCB in writing, informing them of our decision.

ADOPTED

V. Amendment:

to change the words "with a view to possible sister church relations," to "to investigate whether meaningful sister church relations are possible"

Ground:

 Synod 1990 decided to concentrate on relations and contacts with churches which are geographically closer to us (Article 58, Acts of Synod 1990).

ADOPTED

VI. Final Text of Adopted Proposal:

- Synod ensure that a deputyship be mandated to take up contact with these churches "to investigate whether meaningful sister church relations are possible"
- Synod respond to the RCB in writing, informing them of our decision.

Grounds:

- The FRCA have fraternal contacts with RCB's sister churches in Holland and Canada.
- The RCB will have contacts with one more faithful church and involved with the Word of God.
- These contacts will create the possibility of exchange of advice and experience for Reformed faith and practice.
- Synod 1990 decided to concentrate on relations and contacts with churches which are geographically closer to us (Article 58, Acts of Synod 1990).

ADOPTED

VII. Recommendations General Secretary's Report

- The churches take note of the request from the Reformed Churches of Brazil.
- Synod Legana provide the General Secretary Deputy with quidelines relating to the use of the church web site.
- 3. Synod when appointing a General Secretary Deputy also appoints an alternate.

VIII. Proposal:

- To temporarily adopt the current practice of the General Secretary as a guideline for the use of the church web site, as follows:
 - Only organizations which by their constitution restrict their membership to the FRCA are allowed to place material on the web site.
 - b. Each church can have its own address and is responsible for the content within that page.
- To instruct the General Secretary to liaise with those who could potentially add material to the church web site, and recommend guidelines to the next synod regarding the use of the church web site.

ADOPTED

IX. Proposal:

To adopt Recommendation 3 of the General Secretary's report, namely that Synod when appointing a General Secretary Deputy also appoints an alternate.

Article 22 - Reopening

The chairman invites all present to sing Ps 1:1,2.

Article 23 - Training for the Ministry

The chairman proposes that Synod thank Deputies for Training for the Ministry and the General Secretary for their work and discharge them.

I. Materials:

II. Recommendations Deputies Report

Deputies propose the following:

- The 2006 version of the Canadian Book of Praise is taken as the common basis to start our Australian Book of Praise with the understanding that:
- changes agreed upon and approved by our previous Synods (form ordination for office bearers, Australian Church Order, removal of the word Christian from the Apostles Creed (also in Lord's Days 7 and 21), replacement of the Canadian Church Order with the Australian one) are incorporated by deputies into the 2006 Canadian version
- Synod 2009 adopt a new title for the Australia Book of Praise as per the stipulations of the Standing Committee Book of Praise (see Acts of Synod 2003, page 166), e.g. "Worship Book of the Free Reformed Churches of Australia" ("Worship Book" for short), or mandate deputies to select a title, perhaps soliciting feedback from the churches.
- 4. a suitable preface be drafted by deputies in addition to the current preface, which should be retained because of its valuable background information. The new additional preface will explain the need for an Australian edition and include a

- statement that the Standing Committee Book of Praise of the CanRC has permitted the FRCA to use their material, as stipulated by the Standing Committee Book of Praise (see Acts of Synod 2003, page 166), as well as acknowledging the copyright permission of W. Helder.
- adjustments are made to the table of contents where necessary
- 6. the introduction to the church order found on page 655 of the 2006 Book of Praise serve as introduction to the Australian church order, with the revision of the words "Canadian Reformed Churches" to "Free Reformed Churches of Australia. Also the words "Canadian Reformed Churches" in the introduction to the Belgic Confession on page 441 of the 2006 Book of Praise be changed to "Free Reformed Churches of Australia.
- the note at the bottom of page 435 of the 2006 Book of Praise be adjusted to refer to the Australia Book of Praise.
- 8. printing of our Australian Book of Praise is approved at 2009 Synod without the need to come back to the next Synod first. (In the event that Synod does not adopt this recommendation, deputies request Synod to clarify whether or not the churches are permitted to use the interim edition of the Book of Praise with NIV prose section in case we run out of the current edition.)
- If any of the churches wishes to propose changes to the text of subsequent print runs of the Australian Book of Praise, the normal church-orderly way has to be followed, i.e. by way of proposals of Consistories to Classis and if approved, to Synod for consideration and ratification.
- Synod discharges current deputies and appoints a Standing Committee for the Australian Book of Praise.
- Standing Committee for the Australian Book of Praise is to keep informed of the developments in Canada concerning the Book of Praise.
- 12. Synod mandates the Standing Committee for the Australia Book of Praise to implement points 1-7+11 above.

- None of the churches has brought any complaints against the 2006 version of the Canadian Book of Praise and it can therefore be assumed to have common approval in our bond of churches.
- Previous changes have been accepted already and need no further discussion.

- The calculations provided to Synod Rockingham 2003, and included in this report, clearly show the financial benefits of printing the Australian Book of Praise.
- d. The church orderly way helps greatly in refining proposals and working toward unanimity on changes. It also saves Synods much time and proposed changes have already been considered by the churches and consistories well ahead of Synods that eventually deal with possible changes.
- e. An appropriate committee structure and size will provide greater flexibility and continuity of the work at hand.

III. Armadale makes the following proposal:

 That Synod not adopt Recommendations 1 and 8 contained in the Report of the Deputies for an Australian Book of Praise.

That instead, Synod decide as follows:

- 2. That the 2006 version of the Hymn section and the prose sections of the Canadian Book of Praise is taken as the common basis to start our Australian Book of Praise (with the understanding that recommendations 2-7 and 9-12 of the report of Deputies be implemented as proposed).
- That Deputies be charged:
 - to await the decision of the Canadian Reformed Churches in regard to the revised Psalm section of the Book of Praise.
 - b. to examine the text of this revision, and
 - c. to make recommendations to the next Synod in regard to its possible incorporation in the Australian Book of Praise
- Not to proceed with the publication of an Australian Book of Praise until our Canadian sister churches have made a decision in regard to the proposed revision of the Psalm section.
- IV. Launceston expresses a preference for reprinting the Book of Praise with the name of the Australian churches on the front instead of the name of the Canadian churches and with an adjusted Table of Contents; and with the Australian Church Order; but Launceston does not support finding our own (Australian) way forward in modifying the

confessions and the liturgical forms to reflect the usage of modern Bible Translations, for the following reasons:

- a. As the church at Launceston is presently using the NIV in the worship services, we have no problem with using the updated Canadian Book of Praise which has NIV references (see Committee Report 6.2.b). We note, as the deputies and Synod 2003 did, that the NIV has been recognized for use in the churches. (See Deputies' Report, 2.3)
- b. More importantly, if we now begin to create our own (Free Reformed) version of the confessions and liturgical forms, we will also have to maintain these versions and keep them upto-date. We believe that this is unnecessary duplication of work.
- c. With so much travel already happening between Canada and Australia, and as long as we continue to share the use of their theological college and call their ministers and candidates for the ministry, it is good to promote and express the unity that we have by using the same songs and confessions and liturgical forms.
- d. While it may be argued that point A only applies to Launceston and Legana, and not to the churches in Western Australia, consistory requests that synod also consider whether we really want to develop our own Australian version of the psalms and our own selection of hymns. In the current 'climate' in the churches, we believe that it is prudent to follow the general direction of the Canadian Churches where it concerns the usage of a Psalter in our churches.
- e. Synod West Kelmscott, 2006, may have been correct when it stated that "the majority of the churches have indicated a preference to publish our own Australian Book of Praise."

 Whether that means, that the churches were happy to reprint the Canadian book at a cheaper rate, with the convenience of having the Australian Church Order in the back, or whether the churches had another motive for actually developing a distinctively Australian or Free Reformed worship book, is a second question. Again, consistory is in favour of the former, but it does not support the latter.

V. Southern River proposal re Deputies for Australia Book of Praise

That Synod 2009 does not approve the printing of an Australian Book of Praise and that this matter be left for a future Synod.

VI. Albany requests Synod Legana 2009 to make the following decision:

- To discharge the deputies acknowledging that they have fulfilled their mandate admirably.
- That although there is a desire for an Australian Book of Praise, at present the Canadian Book of Praise sufficiently meets our needs.
- 3. To appoint deputies with the mandate to
 - Monitor developments with the Canadian Book of Praise.
 - Resume investigations regarding copyright, printing costs and feasibility of producing an Australian Book of Praise only if the Canadian Book of Praise is substantially altered such that it is no longer suitable for use by the Australian churches.

- Although Synod 2006 acknowledged the church's desire for an Australian Book of Praise, it has not yet been decided to proceed with publishing an Australian Book of Praise.
- Report of Deputies for an Australian Book of Praise contains recommendations regarding how to proceed with a decision to publish our own Australian Book of Praise and to that extent have fulfilled their mandate as stipulated by Synod West Kelmscott 2006.
- Deputies mandate did not allow them to recommend or investigate the feasibility of continuing to use the Canadian Book of Praise and therefore has not featured in their report.
- 4. In monitoring developments with the Canadian Book of Praise, it is noted that
 - The common songbook with the URCNA has effectively been put on hold. Therefore it is expected that the Book of Praise will remain in the same or similar format for quite some time.
 - Synod 2007 has adopted an updated prose section of the Book of Praise with NIV references. The NIV is an acceptable translation suitable for use in the Australian Churches.
 - c. Synod 2007 decided to publish an interim Book of Praise containing NIV references. Our people will therefore be buying that Book of Praise once they become available and we need to maintain uniformity with future versions as much as possible.
- 5. The Australian churches do not exist "in isolation" to other (English speaking) churches. There is an ever increasing

- amount of people traffic between Australia and Canada and therefore uniformity of Psalm Books is very practical and one less cost to incur when travelling or migrating.
- 6. A common Book of Praise for sister churches of the same language is a positive practical aspect of the unity in Christ that these churches have and confess.
- The Book of Praise is published to a very high quality and especially with the use of covers lasts for a long time.
 Changes should therefore be kept to a minimum to avoid constantly needing to update.
- 8. The report to Synod 2003 mentioned a completed unit cost for an Australian Book of Praise to be about \$13.95 for a large order. An unfair comparison was made to the retail price \$26.50 at that time. It should have been compared to the landed cost of buying the Canadian version to ascertain a fair basis whether producing our own would actually be cheaper if produced to the exact same quality.
- A further cost is the purchasing of copyrights. This only adds to the cost of producing our own Book of Praise.
- 10. There is also a question regarding future updates and changes and to what extent the Australian Book of Praise would "automatically" participate or be asked to contribute towards future development costs.
- Although the Canadian Book of Praise has the Canadian Church Order, there is available a small and simple insert of the Australian Church Order that is currently being used by many of our members. Of itself, the different Church Order is not a compelling reason to produce our own Psalm Book.
- 12. There are other minor linguistic and other changes that have been made over the years to the wording of creeds etc. These changes have been around for a long time and have not caused any significant problems. The bookshops might be able to produce small stickers to obscure or add minor changes to some wording in the creeds or forms.
- 13. Further investigation of producing an Australian Book of Praise only becomes compelling if there are significant changes to the Canadian Book of Praise that make it virtually impossible for the Australian churches to continue using it. This could happen if eg a common songbook was developed with the URCNA.

After several rounds of discussion on the deputies' recommendations and the various submissions from the churches, Synod puts Albany's overture to the vote.

3. c. to keep the churches informed of, and elicit responses from the churches regarding developments with the Canadian Book of Praise

XI. Final Text of Adopted Decision and Grounds

- To discharge the deputies acknowledging that they have fulfilled their mandate admirably.
- That although there is a desire for an Australian Book of Praise, at present the Canadian Book of Praise sufficiently meets our needs.
- 3. To appoint deputies with the mandate to
 - Monitor developments with the Canadian Book of Praise.
 - Resume investigations regarding copyright, printing costs and feasibility of producing an Australian Book of Praise only if the Canadian Book of Praise is substantially altered such that it is no longer suitable for use by the Australian churches.
 - c. Keep the churches informed of, and elicit responses from the churches regarding developments with the Canadian Book of Praise.

4. To permit the 2008 interim Book of Praise with NIV prose section for use in the churches

XII. Grounds:

- Although Synod 2006 acknowledged the church's desire for an Australian Book of Praise, it has not yet been decided to proceed with publishing an Australian Book of Praise.
- Report of Deputies for an Australian Book of Praise contains recommendations regarding how to proceed with a decision to publish our own Australian Book of Praise and to that extent have fulfilled their mandate as stipulated by Synod West Kelmscott 2006.
- Deputies mandate did not allow them to recommend or investigate the feasibility of continuing to use the Canadian Book of Praise and therefore has not featured in their report.
- 4. In monitoring developments with the Canadian Book of Praise, it is noted that
 - a. The common songbook with the URCNA has effectively been put on hold. Therefore it is expected that the Book of Praise will remain in the same or similar format for quite some time.
 - Synod 2007 has adopted an updated prose section of the Book of Praise with NIV references. The NIV is an acceptable translation suitable for use in the Australian Churches.
 - Synod 2007 decided to publish an interim Book of Praise containing NIV references Our people will therefore be buying that Book of Praise once they become available and we need to maintain uniformity with future versions as much as possible.
- A common Book of Praise for sister churches of the same language is a positive practical aspect of the unity in Christ that these churches have and confess.
- 6. Although the Canadian Book of Praise has the Canadian Church Order, there is available a small and simple insert of the Australian Church Order that is currently being used by many of our members. Of itself, the different Church Order is not a compelling reason to produce our own Psalm Book.
- Further investigation of producing an Australian Book of Praise only becomes compelling if there are significant changes to the Canadian Book of Praise that make it virtually impossible for the Australian churches to continue using it. This could happen if e.g. a common songbook was developed with the URCNA.

ADOPTED

Article 25 - Adjournment

Article 28 - Appeal of Mt Nasura re Art. 7 Classis North October 2008.

I. Material:

8a - FRC Mt Nasura Appeal re Art 7 Acts Classis North 2008

This item is dealt with in closed session.

Mt Nasura appeals a recent decision of Classis North as recorded in Art 7.1 of the Oct 2008 Acts. This Article reads as follows:

In an appeal a brother requests Classis to decide that the following decisions made by the consistory of Mt Nasura on 7 April 2008 and communicated by letter to the brother on 28 April 2008 are in conflict with the principles of biblical justice and contrary to CO Art 31.

Classis decided to grant the brothers' request.

Grounds: Mount Nasura failed to uphold Classis decisions.

Mt Nasura requests Synod to determine that Classis should not have made the decision above, because Mt Nasura is concerned that this Classis ruling will set a precedent for material relating to objections which were not upheld to be made available outside of consistory. Mt Nasura does not believe this to be conducive to honouring the 6th and 9th commandments.

II. Proposal:

To deny the appeal.

Grounds:

- Mt Nasura expressed concern regarding the Classis decision as setting a precedent for material relating to objections to the election process of an office-bearer. However, the decisions of a classis are made within the context of a specific matter and within local circumstances and do not constitute precedence in Reformed Polity.
- The decision on this appeal reached by Classis is binding only on the specific parties involved. Thus it does not constitute a general pronouncement by which all the church members are bound' (With Common Consent, WWJ VanOene, page 154.)

ADOPTED

Delegates previously involved in the matter abstained from voting.

Synod decides that the item can be included in the published acts.

Article 29 - FRC Darling Downs Appeal re Art 76 Synod 2006

I. Material:

8g - FRC Darling Downs Appeal re Art 76 Synod 2006 re Appeal FRC Mt Nasura

Darling Downs proposes that Synod Legana 2009 rescind Article 76 of the Acts of the Closed Session of Synod 2006. Darling Downs is convinced that Synod 2006 incorrectly applied Article 31 of the Church Order and wrongfully declared this appeal inadmissible on the grounds that "the person who could potentially have been wronged by the decision of Synod Rockingham 2003 is the only one who has the right to appeal." (C.f. Article 76 Acts of the Closed Session of Synod, page 4). Darling Downs believes that the admissibility of Mt Nasura's submission to Synod 2006 should have been judged according to Article 33 CO (and not Article 31 CO).

II. Proposal:

To concur with Darling Downs that Synod West Kelmscott 2006 erred in Art 76 of the Acts of Closed Session

Grounds:

Although decisions made by major assemblies are only binding on the parties involved in the appeal process, Synod West Kelmscott formulated its decision in universal terms as if a person, who could potentially have been wronged by the decision of Synod Rockingham 2003, is the only one who has the right to appeal.

III. Amendment

To add the following words after the word "erred" in the proposal: "in the formulation of the ground"

ADOPTED

The amended proposal is put to the vote and adopted.

Article 30 - Mt Nasura Appeal Article 95 Synod 2006

I. Material:

8i - FRC Mt Nasura Appeal Article 95 Synod 2006

Mt. Nasura sent an overture to Synod 2006 requesting that the sister-church relations with the RCN (Gereformeerde Kerken — vrijgemaakt) be put 'under stress'.

Synod 2006 decided, as recorded in the Acts article 95:

Material: Agenda Item 10d — Overture re relations with the Reformed Churches in the Netherlands.

Proposal: To defeat the proposal of Mt Nasura.

Grounds: Mt Nasura in effect asks for greater awareness and diligence in considering members and ministers from the RCN that come here. Synod regards this adequately covered in the tasks the consistories already have in the exercise as overseers of the church.

In view of the ground for which this overture was defeated, Mt Nasura requests Synod to recognise that it did not receive a proper hearing, on the following grounds:

- 1. Mt. Nasura's request was not for "...greater awareness and diligence..." as suggested in this ground, but that the sister-church relation with the RCN be put under stress. To help define what this stress would be, Mt. Nasura had proposed various changes to the Rules for sister-church relations.
- While being well aware of local responsibility when receiving members with attestations and inviting ministers from sisterchurches to the pulpit, the decisions concerning these relations and their regulations are made by the churches together at synod (see Church Order Article 46) so that there may be unity in action.
- 3. The ground to defeat Mt. Nasura's overture implies that Mt. Nasura or any of the other church is free to put the relation with the RCN under the stress that was proposed without involving the other churches of the bond. This suggests a wrong kind of independence by which the unity of the bond of churches would be undermined. Such action would clearly contravene the Church Order Article 46.

II. Admissibility

Proposal I:

To declare the appeal admissible.

Grounds:

- It was submitted on time.
- 2. The appeal claims that the original overture did not receive a proper hearing.

ADOPTED

Proposal 2:

To deny the appeal of Mount Nasura.

Ground:

 The appeal overlooks the fact that Synod West Kelmscott tabled Mount Nasura's overture not only sub Article 95 but also sub Articles 37, 44, and 47 (as finalized in Article 94). Synod West Kelmscott's decision not to uphold the overture must be read in light of its overall decisions with respect to the RCN. Guarding the Lord's Supper table and the pulpit against members and ministers "who practice or promote the identified deviations" is adequately covered in the consistories' task of oversight.

ADOPTED

Article 31 - Mt Nasura Overture re RCN

I. Material:

II. Admissibility

Proposal:

To declare the overture admissible, but limited to the new grounds.

Grounds:

- 1. Under Art 33 CO, matters may be proposed again provided they are substantiated by new grounds.
- The overture is able to be dealt with on these limited grounds as they are clearly defined in the overture.

The synod shall be held every three years. As long as there are two classes each classis shall delegate four ministers and four elders. In the event that there are three classes, each classis shall delegate three ministers and three elders.

At the close of synod the time and place for the next synod shall be determined and a church shall be appointed to convene it. A synod shall be convened before the appointed time at the request of a classis. Its time and place shall be decided by the church appointed as convening church for the next regular synod.

Grounds:

An amendment to the Church Order is necessary to reflect the decision of Synod to amend the Rules of Synod to accommodate the introduction of three classes.

 94.1 are contrary to Scripture;
 - b. provide new grounds which were not already considered by Synod 2006.
- In denying the request for revision, Synod notes that Article 94.1 of Synod 2006 accepts Amersfoort's decision as largely allaying our concerns, which implies that these concerns were not completely removed.

DEFEATED

III. Proposal:

Synod is not in a position to judge the appeal of West Albany.

Grounds:

- the decision and grounds of Synod 2006 and its supporting documentation do not provide sufficient information for Synod to a make a clear judgment on the matter.
- the appeal of West Albany contains issues that are still a matter of concern to the deputies and is currently on the table of Synod.

DFFFATFD

IV. Proposal Re Article 94.I of Acts Synod West Kelmscott 2006

Grant the appeals of West Albany and Kelmscott only to the extent of acknowledging that Synod West Kelmscott 2006 had incorrect grounds for the decision: to accept Amersfoort's decision as largely allaying our concerns.

Grounds:

- The quotation given in ground b of Synod West Kelmscott 2006 was not based on the official Acts of Synod Amersfoort.
- The quotation given in ground c of Synod West Kelmscott 2006 does not provide clear evidence to support the decision.

ADOPTED

V. Proposal Re West Albany's appeal Re Article 94.II of Acts Synod West Kelmscott 2006

Not to accept the appeal of West Albany against art 94 Acts 2006 regarding divorce and remarriage

Grounds:

- West Albany presents the decision of Amersfoort 2005 as if divorce is not necessarily considered censurable. However:
 - a. Instead of quoting the Synod decision West Albany makes a general statement about an unwillingness of consistories to apply church discipline in cases of divorce. It bases this statement on material that has been selectively quoted and does not do justice to the complete issue;
 - West Albany states that Dutch Synods have not unequivocally answered the basic question about the command to apply church discipline to members

- who contravene God's Word by divorcing their spouse for reasons contrary to God's Word. Synod West Kelmscott also lamented this;
- c. When reference is made to a 'new approach' to divorce and remarriage West Albany quotes from a report which Synod Amersfoort 2005 did not adopt. Even though Synod Amersfoort 2005 states that it is not always clear how and when to exercise church discipline in cases of divorce, Synod does clearly state that divorce is sin and should be firmly dealt with even in situations when church discipline is not yet exercised.

DEFEATED

VI. Proposal

Not to accept the appeal of West Albany against art 94 Acts 2006 regarding divorce and remarriage

Grounds:

- As per Decision 1 and Ground a of Synod West Kelmscott 2006 94.II, the Dutch sister churches did outline a strong and clear Scriptural guidance regarding divorce and remarriage in the Report Principles and Guidelines.
- However, the application (also from the Report), regarding approval for divorce for reasons that go beyond Scripture, were not endorsed by Synod Amersfoort, but Synod did not give explicit guidance or a view on this. This was regretted by Synod West Kelmscott 2006 (Decision 2, Ground b).
- West Albany raises a valid point in that the Report gives room to Consistories to not apply discipline in cases of divorce that go beyond Scripture. However, whether this belongs to the "main thrust" or to the part that was not endorsed by Synod Amersfoort, is debatable.

VII. Amendment

To delete ground 3

DEFEATED

The proposal is put to the vote and adopted.

Article 42 - Book of Praise

I. Material:

10d – Classis South Overture re 28 Additional Hymns and Book of Praise

Classis South proposes:

- To recommend to synod to allow the new additional 28 hymns to be tested outside the church services so that a following synod can determine whether to adopt them.
- 2. To extend the mandate of the Deputies for the Book of Praise to include the following:
 - To scrutinize the revised sections of the Book of Praise, especially the completely revised Psalter, and the 28 proposed Hymns.
 - b. To invite comments from the churches on these revisions.
 - c. To receive and assess comments from the churches about the new 28 hymns.
 - To pass on the findings to the Standing Committee of Book of Praise so that the Standing Committee of Book of Praise can use them.
 - e. To report to our next synod so that it can decide on the above matters

II. Amendment:

To delete recommendation 1 of Classis South Proposal re the additional 28 hymns

Ground:

All hymns should be scrutinized before being recommended to the churches for testing.

DEFEATED

III. Amendment:

To change proposal 1 to read:

to invite the churches to scrutinize and test the 28 additional hymns outside the church services so that a following synod can determine whether to adopt them.

IV. Amendment to Amendment:

To change "28 additional hymns" to "that portion of the 28 additional hymns to be adopted at the CanRC Synod 2010" in proposals 1 and 2.a and 2.c.

ADOPTED

The amended proposal 1 is put to the vote and **adopted**.

V. Amendment:

To add the following:

2.f. to give account to synod of the principles and guidelines used to scrutinize these hymns

ADOPTED

The proposal as amended is put to the vote and adopted.

VI. Final Text of Decision

- To invite the churches to scrutinize and test that portion of the 28 additional hymns to be adopted at the CanRC Synod 2010 outside the church services so that a following synod can determine whether to adopt them.
- 2. To extend the mandate of the Deputies for the Book of Praise to include the following:
 - To scrutinise the revised sections of the Book of Praise, especially the completely revised Psalter, and that portion of the 28 additional hymns to be adopted at the CanRC Synod 2010.
 - b. To invite comments from the churches on these revisions.
 - To receive and assess comments from the churches about that portion of the 28 additional hymns to be adopted at the CanRC Synod 2010.
 - To pass on the findings to the Standing Committee of Book of Praise so that the Standing Committee of Book of Praise can use them.
 - e. To report to our next synod so that it can decide on the above matters.
 - f. To give account to synod of the principles and guidelines used to scrutinize these hymns.

Grounds:

- These new hymns, as the printed version explains, are a needed addition to supplement the sections of the Apostles' Creed which do not receive enough coverage in the present edition. (The hymns are arranged according to topics of the Apostles' Creed.) Thus they are not loosely selected hymns but they have a definite purpose.
- The 2007 General Synod of our Canadian sister churches has received extensive letters with comments on them from the churches and the General Synod has approved them for

- use within the churches. This should give us the confidence to allow the churches to use them provisionally with the aim of testing them.
- 3. We share the Book of Praise with our Canadian sister churches and thus should keep up with these developments. If possible we should try to keep a common Book of Praise. The influence of our larger Canadian sister churches as a bond on us as a smaller bond is very healthy.
- 4. At present there is no body responsible for checking changes and revisions to the Book of Praise.
- 5. The new revisions of the Psalter need to undergo a thorough investigation, especially if we are to use them in the future.
- 6. The Canadian sister churches have invited our input.
- As churches we ourselves need to be proactive in this area of church songs and music. God's worship has always demanded much attention. The Lord wants his worship regularly, and He wants it properly.
- 8. In the past we had deputies look into this, but of late it has not received attention.

ADOPTED

Article 45 - Free Reformed Churches of South Africa

II. Proposal

Synod decides not to accede to the appeal against Article 94.II of Synod West Kelmscott 2006 re Divorce and Remarriage.

Ground:

 Synod West Kelmscott 2006 stated that Synod Amersfoort gave no explicit guidance (to prevent allowance for divorce for other reasons). Kelmscott argues that Synod Amersfoort gave explicit guidance for allowing divorce for other reasons. They base this on phrases such as 'following Christ' (navolging van Christus), 'a lifestyle justifying the coming kingdom' (een levensstijl die recht doet aan het komende koninkrijk), and 'the style of the kingdom' (stijl van het koninkrijk). While these phrases might give implicit evidence that Synod Amersfoort (Art 57, Decision 1 and Grounds a, b and c.) gives room for the new hermeneutics and Christian ethics and leaves room for divorce for other reasons, Kelmscott does not show that Synod West Kelmscott 2006 was incorrect in stating that Synod Amersfoort did not give explicit guidance to prevent divorce for other reasons" (which Synod West Kelmscott 2006 found regrettable).

- The FRC Kelmscott does not appeal the decision under Article 94 (VI, decision 1), being to continue sister-relations with the RCN, but rather appeals Ground (a) which states that "The RCN give evidence of continuing faithfulness to the Word of God, their Reformed Confessions and the Church Order".
- Synod 2006 correctly dealt with the concerns regarding matters of the 4th commandment and Sunday, divorce and remarriage, sacraments in military situations and the manner in which Scripture and the commandments are interpreted and applied in today's circumstances. To this extent Synod 2006 recognised that we do have causes of concern regarding directions of unfaithfulness.
- This concern regarding directions of unfaithfulness does not mean that Synod could not also acknowledge the fact that there was "evidence of continuing faithfulness" (see for example the letters to the 7 churches in Revelation 2 & 3).

II. Proposal

To take a comprehensive approach with regards to this Synod's decision about the sister church relationship with the RCN, instead of

dealing separately and in detail with every agenda item relating to this sister church relationship.

Grounds:

- Most of the submissions express concern about the same synod decisions taken by the RCN.
- Many of the decisions mentioned in ground 1 have come to a conclusion within the RCN. It is therefore difficult to discuss them again in detail with the deputies of our sister churches.
- 3. A comprehensive approach is further justified by the fact that most of these decisions appear to have a common denominator, namely a particular way of interpreting Scripture. This way of interpretation takes its starting point in man, rather than in God's Word, and it may be the result of the influence of a post-modern 'spirit of the age' in the church
- 4. Furthermore, from information available on internet websites, reports from visitors to the RCN, local church bulletins and others, it appears that some local churches show signs of independentism. It appears that decisions of General Synod are not adhered to and that local churches do not exercise mutual discipline.
- Even though the various submissions mention a number of specific points of concern, the major concerns are the changes in interpretation of the Bible mentioned in ground 3, and the signs of independentism mentioned in ground 4.

II. Proposal from Committee 2 Re Request of Darling Downs:

Not to rescind Article 102.3 of Acts of Synod 2006.

Grounds:

- Whilst the FRC Darling Downs requests that Art 102.3 be revised on the basis that it is linguistically poorly constructed, vague and ambiguous and has resulted in much confusion and uncertainty, it does not propose an alternative wording which addresses the concern. To rescind the decision in its entirety does not address the encouragement which Synod 2006 wished to give to consistories.
- By way of Art 102.3, Synod 2006 did no more than encourage consistories. It did not bind the conscience of consistories in any way.

II. Majority Recommendations of Deputies:

- Not to accept the accusations against our sister churches, the RCN, but to defend the honour and reputation of the RCN.
- Not to acknowledge the RCNr as "the lawful continuation of the Reformed Churches in the Netherlands".
- To maintain official contact with the RCNr, so that we can work for reconciliation between them and the RCN, on the basis of truth and love.

- The Letter of the RCNr, dd 4 Feb 2005, in which they explain their liberation of 2003, and the booklet of Sept 2006, in which they defend their liberation and maintain to be the lawful continuation of the Reformed Churches in the Netherlands, have not substantiated their claim that the RCN has no right any more to the title of true church.
- It is a serious matter to separate when it is not warranted.
 The injunctions to remain one in the Lord (e.g. John 17 and

- Eph 4), sometimes even when serious problems arose as in Corinth, can be read repetitively in the Bible.
- 3. The RCNr have the strong desire to be reformed. Therefore we should use contacts with them to urge them to work for reconciliation with our sister, the other Reformed Churches in the Netherlands, who struggle to remain reformed.

III. Minority Recommendations of Deputies:

- While defending the honour and reputation of the RCN by recognising their sincere desire to remain faithful to the Word of God, the Reformed Confessions and the Church Order, there is evidence of worrying tendencies.
- To refrain from deciding at this time whether RCNr is "the lawful continuation of the Reformed Churches in the Netherlands".
- To acknowledge the RCNr desire to be Reformed and continue contact with view to encouraging the RCNr to discuss the issues (and struggles) of concern in humility and love.

- The Letter of the RCNr, dd 4 Feb 2005, in which they explain their liberation of 2003, and the booklet of Sept 2006, in which they defend their liberation and maintain to be the lawful continuation of the Reformed Churches in the Netherlands show that there are serious concerns regarding the direction of the RCN.
- 2. It is a serious matter to separate and may never been done hastily nor without exhausting every effort to maintain the unity of the faith. The injunction to remain one in the Lord (e.g. John 17 and Eph 4), sometimes even when serious problems arose as in Corinth, can be read repetitively in the Bible. It is very difficult for the FRCA to determine whether all efforts to maintain the unity have been exhausted.
- 3. Before the FRCA can conclusively decide that the RCNr liberation was lawful or not, time is needed to address its own concerns of trends in the RCN and evaluate its responses.
- 4. The RCNr show faithfulness to God's Word as upheld in the Reformed Confessions. While refraining from a decision as to the lawfulness of the liberation, the FRCA share many of the concerns for which they liberated from the RCN. Contact with them can be helpful in efforts to maintain the unity of faith with the RCN on the basis of God's Word as upheld in the Reformed Confessions and agreed upon in the Church Order.

IV. Proposal

- Not to accept the accusation of the RCNr against our sister churches, the RCN, that she is not a true church, but to defend the honour and reputation of the RCN.
- Not to acknowledge the RCNr as "the lawful continuation of the Reformed Churches in the Netherlands".
- To acknowledge the RCNr desire to be Reformed and continue contact with a view to encouraging the RCNr to discuss the issues (and struggles) of concern in humility and love.

Grounds:

- Synod has decided to continue sister church relations with the RCN on the ground that "the RCN give much evidence of continued faithfulness to the Word of God, Confessions and the Church Order"

- 3. To be eech the Lord by His grace and blessings to heal the ecclesiastical divisions between the RCN and RCNr.
- 4. To thank the deputies for their work and mandate new deputies to:
 - a. Remain informed about developments in the RCNr,
 - Continue contact with the RCNr with a view to encouraging them to discuss the issues and struggles of concern with the RCN in humility and love.

- Synod 2009 has already decided to continue the FRCA's sister church relationship with the RCN.
- Synod 2009 maintains the position of Synod 2006: "not being able to recognise them as the continuing RCN means that we cannot enter sister relations with them" (Synod 2006 Acts 92.III.4).
- 3. Synod 2009 maintains the position of Synod 2006: "We hear in the voice of the brothers of the RCNr a strong desire to remain reformed" (Synod 2006 Acts 92.III.5.a).
- 4. It is a serious matter to separate and may never be done hastily nor without exhausting every effort to maintain the unity of the faith. The injunction to remain one in the Lord (e.g. John 17 and Eph 4), sometimes even when serious problems arose as in Corinth, can be read repetitively in the Bible. It is very difficult for the FRCA to determine whether all efforts to maintain the unity have been exhausted, realising that there are events at the synodical level as well as at the local church level that influence the decision to separate. Our judgment is therefore limited by these circumstances.

III. Amendment 1:

a) Amend decision 4b to read:

Continue contact and encourage the RCNr to discuss the issues and struggles of concern with the RCN in humility and love.

- b) To amend ground 4 to read:
 - 4. It is a serious matter to separate and may never be done hastily nor without exhausting every effort to maintain the unity of the faith. The injunction to remain one in the Lord (e.g. John 17 and Eph 4), sometimes even when serious problems arose as in

Corinth, can be read repetitively in the Bible. The encouragements to discuss the issues and struggles need to continue because it is very difficult for the FRCA to determine whether all efforts to maintain the unity have been exhausted.

Ground:

Ground 4b is not a ground under decision 4b.

- The recommendation of maintaining an on-line version of this document is consistent with the appointment of this deputyship to provide the churches "easy access to synodical decisions" (c.f. Acts of Synod West Kelmscott, Art 25 Ground a.). Additionally, discretion was provided to the deputies to determine 'the best format in which to publish' the decisions of Synod regarding the Church Order (c.f. Acts of Synod West Kelmscott, Article 25 Ground d.).

Article 80 - Overture Regarding Publication of the Acts

8c - FRC Mt Nasura Overture re Synod Acts publication time delays

Mount Nasura requests Synod to take the necessary measures to ensure that for this and future Synods, the period for publication of the printed Synod Acts does not exceed six months.

II. Proposal:

To deny the overture of Mount Nasura.

- Mt Nasura does not specify what the "necessary measures" are.

8ff - Appeal Rev Bosch Re Classis North

Appeal from Rev. C. Bosch re: the decision of Classis North (Feb. 20, 2009) that denied his request to 'as yet investigate and rectify what [he was] convinced was a miscarriage of justice.'

Classis North (Feb. 20, 2009) decided not to grant the request on the following grounds:

- The appellant has not shown that the family was judged rashly and unheard. Instead the ward elders did visit the family.
- 2. Since the alleged miscarriage of justice took place more than 15 years ago, it is difficult to establish what happened.
- If injustice has been done, there does come a time when we must leave it in the hands of the Lord.

II. Proposal Re Admissibility:

Synod decide to declare this appeal as admissible on the following ground:

1. it follows the process required in Article 31, Church Order.

Article 89 - Appeal Rev. Bosch Re Classis North 20 February 2009

Synod goes into closed session.

I. Material:

8ff - Appeal Rev Bosch Re Classis North

II. Proposal:

Not to uphold the appeal in which Rev Bosch asks Synod to investigate and rectify what he is convinced was a miscarriage of justice, that "the family" was judged rashly and unheard by the Classis Church.

Grounds:

- There is no evidence presented that "the family" was judged rashly and unheard. At the time when this incident took place, it was customary that an appellant submit their appeal to the Classis Church. In this appeal, the appellant was required to thoroughly present its case. The Classis church was under no obligation to give the appellants a personal audience.
- 2. It was also customary at that time for the consistory (whose action or decision was being appealed) to either send a delegation of elders to the Classis church to present its case, or to send a letter with the same intent. The consistory's presentation would be dealt with in closed session, which means that the appellant would not be privy to the consistory's presentation.
- It is not known how the original appellant further pursued the matter. Whilst Rev Bosch mentions an appeal to the Second Appeal Church, he does not interact with its decision. Interaction with this decision is crucial in deciding whether justice was done.

ADOPTED

Article 90 - Deputies for Synod venue and infrastructure Coordination

Proposal:

1. To thank the Deputies and discharge them.

- 2. To appoint new deputies with the mandate to:
 - a. provide and operate an audiovisual system which includes the ability for delegates and audience to follow the discussion clearly;
 - b. provide and maintain a computer system for delegates which includes but is not limited to:
 - i. central data storage
 - ii. convenient printing capability;
 - iii. secure internal email facilities;
 - iv. data backup;
 - liaise with convening committees and coordinate the audio-visual/computer matters of the Synod venue preparations;
 - d. be present and able to assist at all Synod sessions;
 - e. provide full computer and sound support;
 - f. provide a general logistical support role during Synod for delegates.
- 3. To make allowance on the budget for one deputy to attend the next Synod.

- 1. Synod must be able to do its work smoothly through the provision of technical equipment that allows:
 - a. delegates must be able to clearly understand each other;
 - b. the audience to be able to follow the discussion:
 - flexibility to expand as the number of delegates changes;
 - d. a computer system that can service Synod with:
 - i. email facilities
 - ii. central storage so that all delegates can access documents/reports they require;
 - printing service to print documents and reports;
 - iv. central backup system.
- This role has been of great benefit in enhancing the smooth preparation and operation of Synod.
